Α1

Not applicable as the breed does not have CC status at present.

A2

Not applicable as the breed does not have CC status at present.

A3 Specialists

Definition: Judges who are recommended by the UK Eurasier Club and Eurasier Society UK as being suitable to award Challenge Certificates in the Eurasier breed, but not yet approved by the Kennel Club for inclusion on the A2 list.

Requirements:

- 1. Minimum of 7 years judging experience in the Eurasier breed and have the support of the Breed Organisations (KC policy) AND
- 2. To have judged at a Breed Club/Society show or the breed at 4 open shows or Championship shows without CCs with an adequate geographical spread AND
- 3. To have judged at least 25 Eurasiers present AND
- 4. To have attended
 - a. a seminar given by a KC accredited trainer and passed an exam on KC regulations and judging procedures (KC policy) AND
 - b. a seminar on conformation and movement AND
 - c. a KC hands on assessment and passed the assessment
 - d. a Eurasier breed specific seminar or Breed Appreciation Day and passed the MCE and hands on
- 5. To have bred or owned a minimum of 3 dogs when they obtained their first entry into the KC Stud Book (save in exceptional circumstances) AND
- 6. To have stewarded over a minimum of 3 years and at least 10 shows.

A3 Non-Specialists

Definition: Judges who are recommended by the Breed Organisations as being suitable to award Challenge Certificates in the Eurasier breed, but not yet approved by the Kennel Club for inclusion on the A2 list.

Requirements:

- 1. To be approved by the Kennel Club to award Best in Show and/or the Utility group at Championship shows AND
- 2. To be approved to award Challenge Certificates in one or more breeds of the Utility group AND
- 3. To have a minimum of 5 years judging the Eurasier breed, and have the support of the Breed Organisations AND
- 4. To have judged a minimum of 30 Eurasiers present AND
- 5. To have attended those seminars listed under point 4 above, especially 4.d., passing any subsequent examinations.

B Specialists

Definition: Judges with a special interest in the Eurasier breed that the Breed Organisations would support to judge the breed at Open and Championship shows without CCs for an unlimited number of classes.

Requirements:

- 1. To have a minimum of 3 years' experience judging the Eurasier and have the support of the Breed Organisations AND
- 2. To have judged at least 15 Eurasiers present, over a minimum of 5 classes with an adequate geographical spread. AND
- 3. To have attended a breed specific Eurasier seminar or Breed Appreciation Day and passed the multiple choice examinations AND
- 4. To have stewarded at least twice. AND
- 5. To have completed requirements 5, 6, and 7 as listed under B Non-Specilists.

B Non-Specialists

Definition: Judges that the Breed Organisations would support to judge the Eurasier at Open and Championship shows without CCs, with an unlimited number of classes.

Requirements:

- 1. To have a minimum of 3 years' experience judging the Eurasier and have the support of the Breed Organisations AND
- 2. To have judged at least 20 Eurasiers present, over a minimum of 6 classes with an adequate geographical spread AND
- 3. To have attended a breed specific Eurasier seminar or Breed Appreciation Day and passed the multiple choice examinations. AND
- 4. To have stewarded at least twice. AND
- 5. To have taken and passed the Requirements of a Dog Show Judge examination. AND
- 6. To have passed the Points of a Dog assessment, AND
- 7. To have viewed and taken the KC online quizzes on Ring Stewarding and Critique Writing.

C Specialist

Definition: Aspirant judges with a special interest in the Eurasier whom the Breed Organisations would support to judge the breed at Limit and Open Shows, for up to 3 classes.

Requirements:

- 1. To have a minimum of 2 years' experience and involvement with the Eurasier and have the support of the Breed Organisations AND
- 2. To have attended a Eurasier breed specific seminar or Breed Appreciation Day. AND
- 3. To have completed the requirements listed below under C non-specialist.

C Non-Specialist

Definition: Any aspirant judge who has shown an interest in the breed and has the support of the Breed Organisations but does not qualify for any other list.

Requirements:

- 1. To have a minimum of 5 years experience and involvement with pedigree dogs. AND
- 2. To have attended a Requirements of a Dog Show Judge seminar. AND
- 3. To have attended a Conformation and Movement seminar. AND
- 4. To have completed 2 stewarding appointments.

Notes.

In all cases, Judges are included on this list at the discretion of the UKEC & ESUK committees, regardless of qualifications. All judging appointments must be followed by a written report submitted to Our Dogs and the show secretary at minimum. Matters such as appropriate breed handling, breed knowledge and general conduct in and out of the show ring, may be considered. It is the responsibility of all judges to provide an update of their qualifications and judging experience at least every two years. It is also useful, but not essential, to provide details of future appointments if known.

Some leeway on numbers judged MAY be granted when a judge is within 4 dogs or fewer of the requirement IF they can show judging experience in Chow Chow, Keeshond or Samoyed. This is at the discretion of the UKEC & ESUK committees.

Throughout this document: The two Kennel Club recognised breed clubs for the Eurasier are the Eurasier Society UK and the UK Eurasier Club, referred to in this document jointly as the "Breed Organisations" and these are therefore the only two organisations relevant to this subject.
